"Hooked on the Salmon River" Art Exhibition Prospectus

About the exhibit:

"Hooked on the Salmon River" is a themed exhibition that celebrates fishing and the beauty of the Salmon River. The exhibit was developed to feature work from the region's fine artists inspired by this beautiful and swift-flowing river that runs through the small historic village of Pulaski drawing fisherman, nature enthusiasts and tourists from all over the globe. All styles and genres of fine art and fine craft will be accepted from both emerging and established artists 18 and older. Artwork must have been completed in the last two years and will be selected by talented artist and owner of The Gallery Fine Art & Studio located in Sackets Harbor NY, Lawrence C. Barone. (See below for juror bio) The exhibit will be on display from August 28 through October 14 at the Salmon River Fine Arts Center, located at 4848 N. Jefferson St in Pulaski, NY.

Note all work will also be on display and for sale (if applicable) in our online virtual gallery. Should the gallery still be closed due to **COVID-19**. All events and award ceremonies will take place virtually.

Guidelines and Requirements

1. Artists must be 18 and older.
2. All artwork must be themed around the Salmon River. Entries should be appropriate for all ages.
3. All styles and genres accepted in both 2-D and 3-D.
4. Artwork may not exceed 3' in either length or height.
5. 2-D Artworks must be suitably framed/mounted and WIRED to hang. Please Note: 2-D Artworks will be hung from the gallery's hanging system with a 20 lbs. weight limit. Sculpture may not exceed 50 lbs.
6. The juror has the right to disqualify any work not suitably presented, or any work appearing not to correspond to the theme.
7. Artists may enter up to 4 (four) completed works.
8. All works entered must have been created in the last two years and may not have been previously exhibited in a juried show by The Salmon River Fine Arts Center.
9. Artists are responsible for timely drop off or mailing of the artwork within scheduled dates.
10. The Salmon River Fine Arts Center reserves the right to photograph and/or video any submitted work for documentary, educational and publicity purposes.
11. Works on exhibit may be offered for sale. A 30% artist contribution is made to the Art Center for handling any sale. ***No artwork may be removed from the exhibition prior to its closing**
12. Receipt of the completed entry form constitutes your agreement with all conditions and terms described in the prospectus.
13. Artists will be notified via email of acceptance into the show by July 31, 2020.
14. **Drop off artwork:** all accepted work must be hand delivered or mailed to the Salmon River Fine Arts Center, 4848 N. Jefferson St., Pulaski, NY 13142 no later than August 21. The art center is not responsible for shipped artwork that is lost, damaged or delayed during transit.
15. **Pick up artwork:** Thurs - Friday October 15 and 16 from noon to 4pm and Saturday October 17 between 10am and 2pm or by scheduled appointment. Artist may also arrange to have art returned by mail and is responsible for supplying labels and packaging along with prepayment of all shipping charges. **Any work not picked up within 30 days will become the property of the Salmon River Fine Arts Center.**

Awards

Cash prizes including a \$300 Best of Show will be awarded. Prizes will be awarded for categories based on work submitted. Award ceremony will be held at 7:00 PM on opening night, August 28. Details TBD, based on COVID-19 restrictions, but may be held virtually via Facebook LIVE.

Entry Procedure

The following three steps must be completed and received prior to juror review as outlined below:

1. **Send us a completed entry form via email:** with “Hooked Exhibit Entry” in the subject line, no later than Friday July 17. Send to: sr.fine.arts.ctr@gmail.com
2. **Attach images:** Include with your entry form, one digital image for each 2-D work and up to 3 images each for 3-D work. All images must be in jpg form. The file name should be as follows: Artist last name and a shortened version of the title of the work. Files must be 300 dpi resolution, 2 megabyte (200kb) or less in size.
3. **Each digital file must be renamed** and labeled beginning with the artist’s last name hyphen and a shortened version of the artwork’s title. (eg:) Samantha Smith’s work titled “Rowing down the River” might be named Smith-Samantha-Rowing.jpg
4. **Pay the submission fee:** Payment must be received no later than Friday July 17. The non-refundable entry fee is \$25 for members and \$30 for non-members (you may submit up to four works per application for consideration).
