"Hooked on the Salmon River" Art Exhibition Prospectus 2021

About the exhibit:

"Hooked on the Salmon River" is a themed exhibition that celebrates fishing and the beauty of the Salmon River. The exhibit was developed to feature work from the region's fine artists inspired by this beautiful and swift-flowing river that runs through the small historic village of Pulaski drawing fisherman, nature enthusiasts and tourists from all over the globe. All styles and genres of fine art and fine craft will be accepted from both emerging and established artists 18 and older. Artwork must have been completed in the last two years and will be selected by our judge Ann Clarke, Associate Professor of the School of Art and Dean Emeritus of the College of Visual and Performing Arts and Comstock Art Facility for Syracuse University. The exhibit will be on display from August 27 through October 27 at the Salmon River Fine Arts Center, located at 4848 N. Jefferson St in Pulaski, NY. All work will also be on display & sale (if applicable) in our online virtual gallery.

Additional notes:

- Please contact the art center to make an appointment if you are unable to pick up or drop off during regular gallery hours.
- Opening reception may be held via Facebook live, based on NYS Current COVID-19 Guidelines.

Eligibility and Artwork Guidelines

- 1. Artists must be 18 and older.
- 2. Artwork must be themed around the Salmon River.
- 3. Artwork must be original works by the artist and of high quality. Commercially produced copies and reproductions of original works are not eligible for submission. However, fine art prints such as photographs, lithographs, woodcuts, engravings, etchings, screen prints and digital works are acceptable as long as they are labeled as such and numbered as an edition.
- 4. All styles and genres accepted in both 2-D and 3-D
- 5. Artists may enter up to 4 (four) completed works.
- 6. Artwork may not exceed 3' in either length or height.
- 7. All works entered must have been created in the last two years and may not have been previously exhibited in a juried show by The Salmon River Fine Arts Center.
- 8. Artwork content must be appropriate for all audiences, any submissions we deem inappropriate or offensive in subject matter will be rejected.
- 9. The juror has the right to disqualify any work not suitably presented, or any work appearing not to correspond to the theme.
- 10. The Salmon River Fine Arts Center reserves the right to use any submitted work for documentary and publicity purposes.

- 11. Receipt of the completed entry form constitutes your agreement with all conditions and terms described in the prospectus.
- 12. Artists will be notified via email of acceptance into the show on August 6th, 2021.
- 13. Works on exhibit may be offered for sale. A 30% artist contribution is made to the Art Center for handling any sale. Artist checks are mailed w/in 5 days after month end. **No artwork may be removed from the exhibition prior to its closing.**
- 14. **Drop off artwork:** all accepted work must be hand delivered to the Salmon River Fine Arts Center (unless other arrangements have been agreed to), 4848 N. Jefferson St., Pulaski, NY 13142 no later than August 21 (during business hours or by appointment). The art center is not responsible for shipped artwork that is lost, damaged or delayed during transit.
- 15. Pick up artwork: Thursday Saturday October 28 30th, during business hours or by scheduled appointment. Any work not picked up within 30 days will become the property of the Salmon River Fine Arts Center.

Framing

- 1. All artwork must be appropriately framed or matted. Works on canvas must be framed or have gallery-wrapped, finished edges with no staples visible.
- 2. A hanging wire must be firmly attached to the back with screw-eyes or D-rings, and the wire should not exceed the top of the frame.
- 3. Sculpture pieces may not exceed 50 lbs.
- 4. 2-D pieces with saw tooth hangers will not be accepted.

Fee

- 1. A non-refundable \$30 member/\$40 non-member entry fee (good for up to 4 submissions) is due by Saturday July 31, 2021.

<u>Awards</u>

Cash prizes including a \$300 Best of Show will be awarded. The number of awards and categories will be based on work submitted and additional sponsorships received. Award ceremony will be held at 7:00 PM on opening night, August 27. Format and details of the award ceremony is subject to change based on COVID-19 restrictions, and may be held virtually via Facebook LIVE.

Entry Procedure

The following three steps must be completed and received prior to juror review as outlined below:

- 1. **Send us a completed entry form via email:** with "Hooked Exhibit Entry" in the subject line, no later than Friday July 31. Send to: sr.fine.arts.ctr@gmail.com
- 2. **Attach images:** Include with your entry form, one digital image for each 2-D work and up to 3 images each for 3-D work. All images must be in jpg form.
- 3. **Each digital file must be renamed** and labeled beginning with the artist's last name hyphen and a shortened version of the artwork's title. (eg:) Samantha Smith's work titled "Rowing down the River" might be named Smith-Samantha-Rowing.jpg
- 4. Pay the submission fee: Payment must be received no later than Friday July 31. The non-refundable application fee is \$30 for members and \$40 for non-members (you may submit up to four works per application for consideration). Clarke has spent the majority of her professional career in academia as a higher education administrator and faculty member at Syracuse University. In 1998, she joined SU as a faculty member in Fiber Arts/Material Studies. In 2008, she was named the Dean of Syracuse University's College of Visual and Performing Arts, and returned to the faculty in 2016. She has shown extensively across the US, with work in over 20 exhibitions in the last two years, as well as a residency with the Peaked Hill Trust Arts and Sciences Program with Cape Cod's National Seashore.
